Deduct \$.015 per 1/10 degree API for each 1/10 degree below 35.0 degree API.
Deduct \$0.15 per degree API for each whole degree above 44.0 degree API.
- C. Deduct \$0.02 per degree API for each whole degree below 29.9 degree API
- D. Flat
- E. Deduct \$0.02 per degree API for each whole degree below 40.9 degree API
- F. Deduct \$.015 per degree API for each 1/10 degree above 60.0 deg. API.

- G. Deduct \$.015 per degree API for each 1/10 degree above 60.0 deg API.
Deduct \$0.02 per degree API for each whole degree below 40.9 degree API to 35.0 degree API.
Deduct \$0.015 per degree API for each 1/10 degree below 35.0 degree API.
- H. Deduct \$.015 per degree API for each 1/10 degree above 60.0 deg. API.
Deduct \$.015 per degree API for each 1/10 degree below 34.0 deg. API.
